WITNESSETH: That for and in consideration of the sum of Ten Dollars (\$10.00), cash in hand paid, receipt whereof being hereby acknowledged, and other good and valuable consideration deemed valid at law, the said party of the first part does, by these presents, grant and convey unto the said party of the second part with Covenants of General Warranty of Title, all of his right, title and interest, same being an undivided one-half interest, in and to that certain tract or parcel of real estate located on and adjacent to Sand Hill Road, containing 20.98 acres, more or less, known and designated as Parcel E on that certain plat of subdivision for Brenda Leonard as prepared by Geoffrey D. There is further conveyed unto the grantees, their heirs and assigns, a non-exclusive forty (40) foot right of way leading from the road known as Sand Hill Road over an existing road shown on
